## *Who we are*

Established in 1991 by the World Subud Association to serve as the repository for legacies and bequests of Subud members, the Muhammad Subuh Foundation acts as a grant-making body to further the aims of Subud.

The Foundation acts on behalf of approximately 1,000 donors who deeply care for humanity and who therefore desire to see Subud continue to develop in the world.

To date, the majority of the Muhammad Subuh Foundation's charitable giving is focused on assisting Subud groups to obtain and improve their meeting facilities, as well as supporting social projects in conjunction with Susila Dharma International Association.

## *What we do*

The Muhammad Subuh Foundation supports the development of Subud by providing financial assistance in a wide-range of areas, including social and humanitarian work, cultural endeavors, and youth projects - to improve the lives of our fellow human beings in meaningful ways.

This support is in addition to providing for the long-term needs of Subud such as meeting places, archives, & strengthening the capacity of our organization.

However, the Muhammad Subuh Foundation is more than a mechanism for giving. The Foundation works as a partner for donors, helping to identify where donations can have the greatest impact, guiding donors through each complex step involved in international philanthropy.

The Muhammad Subuh Foundation makes the process easy for donors, while implementing due diligence to ensure that grants are distributed effectively and have maximum impact, all the while staying in strict compliance with U.S. laws and regulations governing charitable giving internationally.

# Chairman's letter

I am glad to report that despite many challenges the year 2010 was reasonably successful for the Muhammad Subuh Foundation. In January four out of seven trustees had been newly elected to the Board, which immediately set out to learn about and continue the programmes and projects initiated and developed by the previous Board of Trustees. At the same time ways and means to strengthen the Foundation were explored with the aim to improve its ability to serve the long term development of Subud.

As described in more detail in this report the Foundation was able to pursue its objective by funding a number of worthwhile programmes and projects with a total amount of about US\$190,000. Funds were granted to five Subud Houses in Nigeria, DR Congo, Colombia and Ukraine. In cooperation with Susila Dharma International Association funds were also granted to the International Child Development Project (ICDP) and the Lemba Imbu Community Health Centre Project in the DR Congo. Grants awarded to the Subud Education Fund were used for scholarships to students in Indonesia, Colombia and the DR Congo. The Foundation also contributed a grant towards revamping the website of Subud International Cultural Association, and as every year the World Subud Association received a sizable grant for its long term programmes.



A new investment policy and strategy, developed by the Foundation's Investment Advisory Committee, was executed. The objective was to create a balance between the risks from increasingly volatile financial markets and achieving acceptable returns, as well as reducing fund management costs.

Also the Foundation's Policy on International Giving was reviewed with assistance from a reputable US law firm. While the new policy unfortunately increases the work load both for the MSF management and the grantees when preparing grant documentation, it is nevertheless essential in order to comply with today's more stringent and complex laws and regulations.

Over the last five years the Muhammad Subuh Foundation has granted more than US\$900,000 to programmes and projects serving its purpose. During the same period its net assets grew by 13% or in average 2.5% per year. This was possible thanks to donations and bequests from a large number of persons supportive of the Foundations aims, but also because in earlier years administrative expenses were kept low. However looking forward, the future seems to offer some challenges. The need for a stable and professional management of the Foundation has increased and this means increased costs. While in 2008 and 2009 around 15% of income was spent on internal administration, in 2010 it was 30%. But in 2010 donations from private persons and particularly enterprises also shrunk dramatically. This is a cause of concern because in the past five years almost half of the income came from private and enterprise donations. The Foundation's net asset base of about US\$3.7 million by the end of 2010 can only produce a modest income and selling off assets would endanger its long term objectives. In other words: the future potential of the Foundation's ability to serve its aims to a large degree depends on our joint ability to attract more donations.

And at the same time we look forward with great interest to learn about both new and established projects that can help develop Subud long term and support

social and humanitarian developments. Let us know how MSF can assist when putting them into reality or taking them to the next level.

We are proud of and grateful to our committed donors and friends who over the years have supported our many projects. With your continued grants and backing I am confident that the Foundation will be able to maximize the social impact of your donations.

I wish my successor, Bachtiar Lorot, the trustees and the management team all the best and much success in the further development of the Muhammad Subuh Foundation.

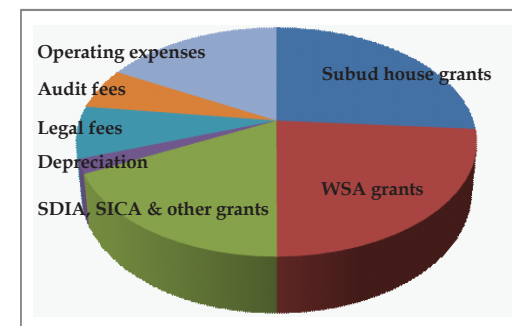

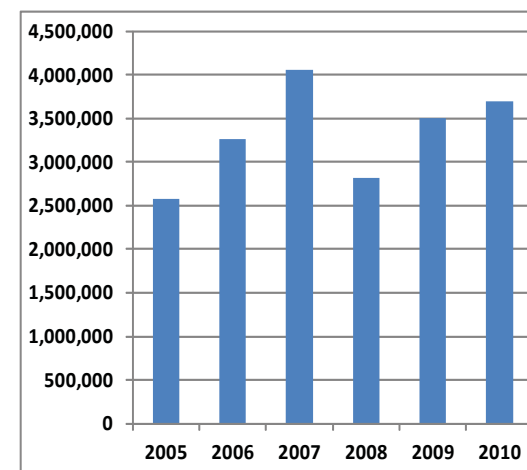

# Funds

## *Non-Endowment Funds*

A non-endowment fund allows both the earnings and the principal of a donation to be used for granting. It is a non-permanent fund.

**General Fund** (also known as the Annual Programs Fund) provides support for Subud premises, translations, Bapak's talks, archives, infrastructure capacity-building, helper travel, and many other worthy programs of the World Subud Association.

## *Field of Interest Funds*

A field of interest fund allows donors to contribute at any level to particular areas of interest simply by earmarking their donations.

## *Endowment Funds*

An endowment is a permanent fund through which net investment proceeds are available for grant making in perpetuity. An endowment fund at the Muhammad Subuh Foundation is one of the best ways to leave a lasting legacy for Subud.

**Bapak Legacy Fund** is designed to promote lasting financial capacity for the Subud Association. It is a permanently-restricted fund whose principal is held in perpetuity and only the income and appreciation on the funds may be distributed.

**Francois & Lucienne Farkas Endowment Fund** supports educational opportunities and programs for young people in need around the world, and helps make Bapak's talks widely available.

**Leonard & Aisah Parker Endowment Fund** benefits the development of Subud houses in Australia.

# Grants

## Subud Houses

### **Subud Calabar, Nigeria**

Funding of US\$22,000 was awarded by the Foundation to Subud Calabar for the purchase of a Subud house. The house will provide a meeting space for the members of Subud Calabar: 22 men and 7 women.

### **Subud Lagos, Nigeria**

A \$3,468 grant was made to Subud Lagos to find premises to rent for a couple of years in order to meet and practice the spiritual exercise of Subud. It is hoped that this will strengthen the group, giving them the time and support to then decide where and how to meet in the future. The Subud group, comprising 11 men and 4 women, had been meeting in one of the members' houses three times a week.

### **Subud Kinshasa, DR Congo**

Subud Kinshasa has been meeting and worshipping together for many years now, but in a very small space. About three years ago, during a visit by some members of the Subud World Council, a request for funds was made to MSF for a new and bigger hall. This was deemed to be too costly so a second application was made the following year for a smaller sum which was then granted.

The Kinshasa Subud members meet both in the city and in several small groups dotted around the city. In 2010, they received a grant of \$25,000 and a loan of \$15,000 from MSF to acquire new premises. Unfortunately, due to the economic situation worsening yet again, the price of the house which they had found had increased to such an extent that it became out of reach by the time the money arrived. Another property, responding to the criteria given, was later found and purchased by the group.

### **Subud Bogota (Teusaquillo), Colombia**

Subud Teusaquillo was given a loan of US\$1,500 and a grant of US\$3,500, in August 2010. The purpose of the grant was to renovate the house in order to generate rental income, particularly to renovate the kitchen and bathroom.

### **Subud Cherkassy, Ukraine**

A grant of US\$8,000 was approved by the Foundation to Subud Cherkassy for the purchase of land adjacent to their existing Subud house. The plot of land was acquired and the certificate of ownership was obtained 24<sup>th</sup> February 2011. The group is active and there are currently 11 men and 16 women, including some new members (5 men and 1 woman) who joined in 2010. The house is still well used with its main purpose being for group meetings to do the spiritual exercise of Subud three times a week. The halls are also rented to various groups, which provides additional income to help pay for utilities.

# Grants Projects

## Susila Dharma International Association (SDIA)

### **International Child Development Project (ICDP)**

ICDP has developed projects worldwide but most of these projects receive funding directly without contributing to ICDP. A review of ICDP International revealed that the organisation should focus on certain areas such as, among others, the formation of international consultants and increase its fundraising capacity. ICDP therefore approached MSF for funds, via SDIA, to help them build a sustainable operation.

A grant of US\$4,000 from MSF received in 2010 was used to carry out a broad consultation with different stakeholders, and develop a strategic plan and a plan of action. MSF funding, complemented by GHFP funding, was also earmarked for the appointment of a part-time marketing manager. SDIA believed that these approaches would help ICDP find its financial stability during 2012. SDIA reports that the situation of ICDP international has now improved and appears to have better financial prospects.



## Susila Dharma International Association (SDIA)

### **Lemba Imbu Community Health Centre Project, DR Congo**

In 2010, MSF provided \$20,000 to support this pilot project, situated on the outskirts of Kinshasa, which is serving an isolated community of about 18,000 people. This MSF grant has been used to cover the activities of MDA in the training of a community network of volunteer health workers, the training of a Community Health committee to manage the centre and the recruitment and training of a team of medical and administrative staff who will operate the centre. An additional MSF grant of \$1400 has been given to cover administrative and management expenses for this initiative such as travelling to the DRC and monitoring this project with other partners.

This is an innovative project, involving a close collaboration between several key partners: SDIA, SD DRC, the Subud Group of Lemba Imbu, the NGO African Doctors (MDA) and the community of Lemba Imbu.





### **Subud International Cultural Association (SICA)**

#### **SICA website development**

An application to MSF for a grant of US\$5,000 was made by SICA to complement the funds already raised to revamp the existing SICA website with a content management system to allow multiple users from around the world to add content. Updating and rebuilding that site will enable it to become more accessible and usable. It is hoped that the new site will also provide resources, services, news, inspiration and information. SICA anticipates that it will also provide access to tools for marketing and professional development and be used for networking. It is planned that it will also offer online interactive workspaces for the creative expressions of Subud members. In the words of the SICA chairperson, Latifah Taormina, "We are very grateful for the MSF's grant in support of our creating this new website." The new website [www.subud-sica.org](http://www.subud-sica.org) was launched in December 2010.



### **World Subud Association**

#### **Talk translations, international helper travel, archives, History of Subud project, and the tape preservation unit**

In 2010 MSF provided US\$59,740 to the World Subud Association (WSA) to ensure continued progress in the selected programs of the WSA listed above. These particular programs correspond to the strategic goals of the Muhammad Subuh Foundation, and the Foundation considers these services to have long-term benefit for the development of Subud.

### **WSA Care Support Team**

#### **Subud Education Fund - scholarships**

A grant from MSF of US\$5,000 was awarded to the Subud Education Fund (SEF) in 2010. A further US\$3,815 was transferred from the Emergency fund, since it had not been fully used, to add to the MSF grant, making a total amount of \$8,815 for SEF, which was used to assist an Indonesian third-year Nursing School student covering an eight-month internship at a hospital; a Colombian student in Social Work at University; and, 19 DR Congo students including 5 elementary school students, 7 secondary school students, and 7 university level students: 2 civil engineering students, 1 electrical/mechanical engineering student, 2 students at nursing school, and 2 law students.
