

- 2014 World Congress Mexico
 - Regular calls set up with Maya and C O Team.
 - Marston Gregory, US National Treasurer, working on Registration fees and financial planning
 - Negotiations with 2 different venues have begun
 - Maya plans to visit in Jan 2012
 - Exact dates for World Congress to be agreed January 2012
- 2012 WSC Meeting at Americas Gathering in Vancouver
 - Dates agreed: pre meetings 18, 19 June; WSC meeting 20 -26 June; Interactive Wings & Gathering 27-28 June.
 - Visa information gathered & process beginning
- WSA Care Support Disaster Relief fund to be co-ordinated by SDIA.
Agreement of how this will work has been drawn up for agreement by all parties.
Agreement reached to use WSA Care Support structure for appeal for a member's sons' medical treatment.
- WSHPP – Urgent need recognised for plan for long term use of Wisma Subud as International centre. See Background briefing for WSA BoD for detailed info.
- KIC Liquidation Trust – Directors appointed and legal documents drawn up, ready to be signed. Sent to directors for approval.
- WSA Archives & MSF – Legal documents including Contract of Works, annexes, contract with MSF & Memnon etc. drawn up and agreed. 'Ownership in perpetuity' agreement to be drawn up. All expected to be signed before the end of 2011. Bachtiar and Armand to visit Memnon.
- WSA Database – some progress. WSA ownership of data being confirmed.
- WSA Finances
 - Fundraising Strategy – Plan has been devised, 5 countries approached
 - Tax efficient donations – information from 5 countries being collated
 - Amalgamated accounts – WSA's partner organisations approached for co-operation and information
 - 'Reserves' Policy – in the process of being agreed before recommendation put to WSC.
 - Wells Fargo account in US set up in part for online donation capability
 - On-line Credit Card donation facility set up thru' Network for Good'
 - 2012 WSA BudgetV5 ready for BoD approval
 - Subud Nigeria – joint GHFP & WSA funding for Congress set up & used laptop delivered
- WSA Exec Team
 - * Secretary and Admin roles re-assessed and some tasks passed to Silvana
 - Samson Rogers joined the team assisting with SWN and subud.org
 - Publications officer – replacement for Armand Bisson needed. Job is now Translations Co-ordinator.
 - Angela Rivera in Colombia, is assisting with the database
- Copyright of Subud name in US
 - February 2011 - Application filed in five classes.
 - October 2011 – Deadline for submitting additional information to US examining attorney.

In response: DVD made of Bapak's only talk to non-Subud audience fulfilling audio/visual criteria, text for some classes revised and materials mentioning Subud's presence at Council of World Religions, interfaith meetings and UN participation were important to 'showing the significance' of Subud.
